



## 2021 MUNICIPALITY OF ARRAN-ELDERSLIE EMERGENCY PREPAREDNESS WEEK WIN A 2 PERSON DELUXE DISASTER PREPAREDNESS KIT CONTEST (the "Contest")

### **CONTEST PERIOD**

- 1) The Contest opens on Saturday May 1, 2021 at 12:00:01 a.m. Eastern Time ("**ET**") and closes on Sunday, May 30, 2021 at 11:59:59 p.m. ET (the "**Contest Period**").

### **ELIGIBILITY**

- 1) The Contest is open to all full time and seasonal residents of the Municipality of Arran-Elderslie (the "**Municipality**") except employees (and those with whom such employees are domiciled) of the Corporation of the Municipality of Arran-Elderslie (the "**Sponsor**"), its affiliated companies or agents, and the Contest judge(s).
- 2) Limit one (1) entry per resident during the Contest Period.

### **HOW TO ENTER**

- 1) To enter this Contest a resident, during the Contest Period, must submit answers to the multiple choice examination (the "**Entry**") available on the Sponsors web site at <https://www.arran-elderslie.ca/en/living-here/emergency-planning.aspx>.
- 2) Alternatively a resident may submit a paper copy of their answers to the multiple choice examination (the "**Entry**") at the Office of the Sponsor or at any other location(s) authorized by the Sponsor.

### **DRAW AND WINNER SELECTION**

- 1) No later than five (5) business days following the close of the Contest Period in Chesley, Ontario one (1) eligible entrant will be selected (the "**Selected Entry**") by random draw from all eligible entries received during the Contest Period. The odds of winning depend on the number of eligible entries received.
- 2) Before being declared a winner: The Selected Entry will be graded by the Contest judge(s) and a minimum grade of 70% or higher must be earned (the "**Grade**"). If the Selected Entry fails

to meet the Grade requirement, the Contest Judges will select and grade additional entries until such time as a Selected Entry achieves the Grade. The Contest judge(s) will inform the Sponsor of the Selected Entry that meets the Grade requirement.

The Sponsor will then call or email, and the entrant will be required to sign and return upon receipt of the Prize a declaration of eligibility and a liability/publicity release, which:

- a. confirms compliance with the contest rules;
- b. releases the Sponsor and the Contest Judges and each of their respective officers, directors, agents, representatives, successors and assigns from any liability in connection with the Contest, the entrant's participation therein and/or the awarding and use or misuse of the Prize or any portion thereof; and

NOTE: The Prize does not include, and the Sponsor will not pay for, transportation to and/or from the collection point for the Prize. The collection point shall be the Municipal office located in Chesley, Ontario.

- 2) The Prize must be accepted as awarded and are not transferable or convertible to cash. The Prize will only be awarded to the resident who is named in the Entry.

## **PERMISSION TO USE SELECTED ENTRANTS NAME**

- 1) The selected entrant, by accepting the Prize, acknowledges and agrees that their name and picture may be posted on the Sponsor's website, where it may be viewed by the Sponsor and the general public.

## **GENERAL**

- 1) By entering the Contest, each entrant agrees to abide by these Contest Rules. This Contest is subject to all applicable federal, provincial and municipal laws. Void where prohibited by law. The decisions of the Sponsor with respect to all aspects of this Contest are final and binding on all entrants without right of appeal.

- 2) Sponsor reserves the right to cancel, suspend, withdraw or amend this Contest in any way, without prior notice or obligation, in the event of an error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure or any other cause beyond the reasonable control of the Sponsor that interferes with the proper conduct of this Contest as contemplated by these Contest Rules. Any attempt to deliberately undermine the legitimate operation of this Contest is a violation of criminal and civil laws and should such an attempt be made, the Sponsor reserves the right to seek remedies and damages to the fullest extent permitted by law, including criminal prosecution.
- 3) Sponsor's right to use your Name: You acknowledge that your Name may appear on the Sponsors website and may appear in other electronic and print materials related to the Contest.
- 4) All Entries are subject to verification at any time and for any reason. The Sponsor reserves the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsor): (i) for the purposes of verifying an individual's eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any Entry entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Rules.
