# 6. Public Meeting(s)

6.1 – SRFIN.21.04 – Fees and Charges 2021

Treasurer, Tracey Neifer, presented the proposed 2021 Fees and Charges to Council.

As it is best practice to complete an annual review of fees & charges imposed by the municipality, a change in fees is being recommended by the Management team. The Treasurer discussed the proposed changes with Council. This is an annual update.

6.2 – SRFIN.21.05 – Building Department 2021 Operating Budget

Treasurer, Tracey Neifer, presented the proposed Building Department 2021 Operating Budget to Council.

The municipal budget presented on January 11th, 2021 SRFIN.21.03 noted the exclusion of the Building Department from the annual presentation of the municipal operating budget for 2021. In accordance with section 290 of the Municipal Act, 2001, S.O. 2001, c.25, the municipality is required to prepare and adopt a budget. The Building Department, however, is governed by the Building Code Act and the Building Code, which requires that:

- ✓ These services should be self-supporting.
- ✓ Delivery of the building department services should generally not affect the municipal budget.
- ✓ The fees are not permitted to exceed the anticipated reasonable costs of the municipality to enforce the Building Code Act.
- ✓ Building permit fees can include a component designated for a reserve fund.
- ✓ The reserve fund can only be used for costs of delivering services related
  to the administration and enforcement of the Building Code Act.

The budget has been prepared based on the following considerations and assumptions:

- ✓ A review of 2020 year-to-date results and 2020 Budget.
- √ 1.75% wage rate increase, following Arran-Elderslie's collective agreement for union employees.
- √ 2% inflation on materials and supplies.
- √ 10% increase on insurance, based on 2020's renewal experience.
- ✓ Inclusion of direct costs attributed to Covid-19 pandemic administrative and PPE.
- $\checkmark$  Assumption that training, education, and conferences will resume in 2021.

While the budget reflects a \$7,000 decrease in revenues, operational expenditures have increased \$33,081. The most notable variances represent 93.5% of the increase:

- ✓ Wages and benefits increased by \$20,924
  - In 2021 a new position was approved for a Deputy Clerk/Administrative Assistant, which is being cost shared between General Government and the Building Department. In addition, the budget includes inflationary increases and assumption of annual grid moves
- ✓ Contracts increased by \$10,000
  - In 2020 an agreement was established for shared services of a Municipal Law Enforcement Officer with the Township of Chatsworth. Arran-Ellerslie's share of costs are split between Building Department and Property Standards

The 2021 Operating Budget requires a transfer from Reserves of \$28,744 to cover planned expenditures. Granted that a draw on reserves is not ideal, the current reserve position has grown from \$30,000 to an estimated \$184,091 planned for 2021.

# 7. Delegation(s)

7.1 – Grey Bruce Telecom – Richard Gils

Mr. Gils made a presentation to Council

He noted in 2020 GBTel was awarded SWIFT funding to connect Sauble Beach to Allenford:

- Target speeds between Sauble-Allenford-Tara trunk to exceed speeds of 100gbps+ on backbone trunk
- Access of home speeds ranging from 25mbps to 1gbps (depending on pricing/package of what the customer is looking for)

In the summer of 2020, they began fibre build to connect its network between Tara to Allenford.

In 2020, GBTel was awarded SWIFT funding to connect Sauble Beach to Allenford:

- SWIFT network to inter-connect with existing fibre trunk between Allenford and Tara
- All builds incorporate an "end-to-end" design comprehensive intent to build out trunk line AND home/business connections (i.e., the network is for the towns/villages AND the customers along the trunk path)
- Target speeds between Sauble-Allenford-Tara trunk to exceed speeds of 100gbps+ on backbone trunk
- Access of home speeds ranging from 25mbps to 1gbps (depending on pricing/package of what the customer is looking for)
- North part of Tara to start to see benefits of this build as project is completed
- Target completion date is between Year-End 2021 to 2022.

GBTEL plans on extending its Tara build in Year-End 2022 and 2023. The target is to reach 100% of all interested homes and businesses in Tara by Year-End 2023.

Council thanked Mr. Gils for his presentation.

Council supported the CAO drafting a letter of support for GBTEL.

7.2 – Arran-Elderslie Economic Development Strategic Plan

Council waived Section 7.5 of the Procedural By-law to allow for a longer delegation for this item.

Aileen Murray, David Campbell, and Kevin Curtis from Mellor Murray Consulting presented the Arran-Elderslie Economic Development Strategic Plan to Council. She suggested a taskforce to support the Community Development Coordinator.

Council thanked the group for their presentation.

7.3 – Alicia and Trevor Gibbons – 381 Goldie Street, Paisley

Mrs. Gibbons made a presentation to Council regarding their property.

They would like to have their home ready to put up for sale by spring. In order to successfully sell their home, they believe they need to obtain the shore road allowance along the river and either look at purchasing it or having an easement on the property.

They have been in talks with both Saugeen Valley and an engineer who they will be hiring to assess the documents they need to move forward to have approvals met by Saugeen Valley on the berm they previously constructed.

They are hoping Council and themselves can come to an agreement best for both parties involved, and one that is not only time efficient but also one that is cost efficient.

Council directed staff to meet with the Municipal lawyer in this regard to discuss available options.
